Conditions under which space in the Showground area is let for use:

1. Cost of the space is \$45 per metre frontage by 6 metres deep. (Min. frontage is 3 m). Alternatively, for a site with a marquee, lights, trestle and 2 chairs the cost is \$350 for 3m x 3m, \$600 for 6m x 3m or \$850 for 6m x 6m. Larger marquee sites are available by negotiation.
2. Guy ropes of any tents or awnings, vehicles and other items, which form part of the stall, are to be within the measurement of the space let.
3. All stalls must be erected within the boundaries of the site and any items, including vehicles, which are not part of the stall must be removed from the Showground before 3:00 pm on Friday and 8:30 am on Saturday. Vehicle speed to be limited to 10km/hr.
4. Sellers are required to observe Kelmscott Agricultural Society (Inc.) sponsorship commitments and, at the time of applying for space, should enquire whether the sponsorship requirement applies or affects the selling of items as described in the stall holder's application.
5. Stall holder Passes to the Showground will be issued on the basis of **TWO** passes for each 3 metres of space frontage for each day the site is let. Additional staff will be required to pay the current admission fee. **Passes will be collected at the gate on entry.**
6. Stall holders and exhibitors are responsible for their own public liability insurance cover. Kelmscott Agricultural Society (Inc.) is not responsible for damage, loss, theft or personal injury.
7. **Due to a safety provision of the supplying authority, electricity is available only for the lighting supplied to each site and is at no charge. Stallholders must provide their own extension cord to the outlet and it shall have a current certificate of safety issued by a licensed electrician. Vendor's caravans shall be electrically tested and shall show a compliance plate. Electrical power supply for equipment is unavailable and stallholders must provide their own power supplies if additional power is required.**
8. Stall holders and exhibitors shall observe the provision of the Health Act and any other appropriate Act or Regulation that would apply. Food stall holders must supply a copy of their Special Events approval from the City of Armadale.
9. No raffles may be conducted and the sale or distribution of water pistols or sparklers is strictly forbidden on the Showground.
10. Stall holders are requested to maintain their area tidy and free of litter, and to remove all packaging from the site when leaving.
